

Solignum Timber Decking Stain

Wood Stain for Decks

DESCRIPTION

SOLIGNUM TIMBER DECKING STAIN is a low maintenance, organic solvent based protective coating which imparts colour to the wood whilst allowing the grain to show through.

It has water-shedding properties, allows the wood to breathe and is suitable for use in high and low temperatures and coastal environments.

Solignum Timber Decking Stain is available in a range of colours. A separate colour chart is available.

When applying Solignum Timber Decking Stain to treated timber, the final colour will depend on the colour and condition of the deck timber.

PROPERTIES

Flash point:42°CDensity (kg/m³)0.75 – 0.85Drying time:4-6 hours. Allow 24 hours minimum
between applications

RECOMMENDATIONS FOR USE

It is recommended that all non-durable timber for external use is adequately pre-treated with a suitable preservative. Technical Data Sheet TDS 1687 (INT)

Preparation

Wood should be unweathered, bare, dry, free from mould, dirt, bark, paint, varnish or polish. Weathered surfaces should be sanded back to sound wood and preservative treated.

Finished or rough sawn wood may be coated. Moisture content should be less than 21% at the time of coating.

Solignum Timber Decking Stain may not properly adhere if applied to surfaces, particularly horizontal surfaces, which are retentive of surface moisture from rain, fog, mist, dew, etc.

Ensure contents of can are thoroughly mixed before and periodically during application. It is recommended that a trial area is first coated to ensure a satisfactory finish. One application to bare wood serves as a primer.

When re-decorating existing Solignum Timber Decking Stain, use a stiff, non-wire brush to remove loose extraneous material. For sawn timber, wash down with a suitable fungicide and allow to dry. Planed timber should be lightly sanded to improve adhesion. Re-coat with one or two applications as required.

Application

Application by brush: Apply evenly with a full brush, allowing the first coat to dry thoroughly before a subsequent coat or overtreatment is applied. Avoid overbrushing.

Application may also be by spray, most types of equipment being suitable (a trial is recommended to establish the best settings for a particular piece of equipment); or by immersion, where care must be taken to ensure complete mixing of the Solignum Timber Decking Stain before and regularly during operation.

NB: Solignum Timber Decking Stain is unsuitable for application by roller.

Solignum Timber Decking Stain should be applied during dry and if possible, windless weather conditions above 5°C. Care must always be taken to protect immediate surroundings during application. Plants should be protected from contact with coated timbers until the treatment is thoroughly dry.

Harmless to humans, plants and animals when dry.

Cleaning

Clean equipment after use with white spirit or similar solvent.



PACKAGING and STORAGE

Solignum Timber Decking Stain is supplied in 5 litre packs.

Store in cool, well-ventilated area. Keep container tightly closed. Must only be kept in original packaging.

SAFETY INFORMATION

Flammable.

Repeated exposure may cause skin dryness or cracking.

Toxic to aquatic organisms, may cause long-term adverse effects in the aquatic environment.
